Personnel Policy Revision <i>TFC presented a proposed revision to Personnel Policy PerP2.3 to include grandparents as immediate family when employees utilize sick time or bereavement leave.</i> <i>SA made a motion to accept the personnel policy revision as presented. LG seconded the motion. Motion passed.</i> 4. Firefly/SLAES LIHTC Housing Project - Update <i>TFC reported that Firefly is hoping to complete their LIHTC application this year for their proposed housing project. They are in the process of securing a piece of land and they will be in attendance at the next board meeting to provide an update.</i> 5. July Board Meeting <i>TFC reminded board members that there is typically no meeting in July due to vacation schedules and a lack of agenda items. It was agreed that the Board will not meet in July.
